Bacopa Complex is a unique combination of Bacopa herb, Schisandra fruit, Eleuthero root and the essential oil of Rosemary leaf.*

Extracts of herbs may be ‘standardized’ – this means they must contain a certain amount of important constituents. Top quality Bacopa extracts are standardized for bacoside content (as bacoside A) and top quality Eleuthero extracts are standardized for syringaresinol diglucoside content (as eleutheroside E).*

How Bacopa Complex Keeps You Healthy

Enhances mental clarity, supports cognitive function and supports normal memory function

Bacopa has been used by natural clinicians in India for thousands of years, and is mentioned in ancient Ayurvedic texts including one dating back to the 6th century. In this text, Bacopa is recommended to support cognitive (mental) performance and help with concentration.^{1*}

Two randomized, placebo-controlled trials have investigated the effect of standardized Bacopa extract. In healthy volunteers aged between 18 and 60 years, Bacopa had a positive effect on mental performance. These results were statistically significant, and maximum benefit was shown after 12 weeks. Participants did a series of standard tests that measured the speed of processing information, the rate of learning and the use of memory.² In the second trial involving volunteers aged 55 to 70 years, Bacopa significantly supported healthy memory function.^{3*}

Uncontrolled trials conducted in the former Soviet Union as early as the 1950s found that Schisandra improved mental performance in healthy volunteers and workers.⁴ Eleuthero has also shown this effect in clinical trials.^{5,6*}

Eleuthero has been used traditionally in China to relieve mental strain.⁷ In a placebo-controlled trial Eleuthero improved mental performance in those requiring nervous system support.⁶ Another controlled clinical trial found that Eleuthero improved well-being and supported memory in volunteers (36 to 58 years old). These results were statistically significant.^{8*}

Rosemary leaf has been used for centuries to strengthen memory and enhance mental alertness.⁹ The essential oil is likely to contribute strongly to this activity.*

Nourishes the nervous system

Bacopa and Schisandra have been used traditionally for nervous tension.^{1,10} Eleuthero has been used traditionally in the Chinese herbal system for conditions of temporary mental and emotional stress and to help calm the nerves.^{11,12*}

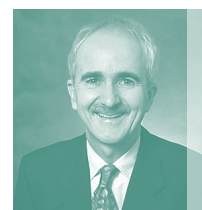

In a randomized trial, standardized Bacopa extract significantly reduced nervous tension compared to placebo in healthy volunteers. Maximum benefit was shown after 12 weeks.² In a randomized controlled trial, Eleuthero extract improved the quality of life in elderly patients and significantly improved social function and mental health scores.^{15*}

Eleuthero helped volunteers adjust in situations of environmental stress.^{5,6} In a randomized controlled clinical trial, with healthy volunteers, Eleuthero reduced heart rate responses to a stressful mental task.^{11*}

Uncontrolled trials conducted in the former Soviet Union showed that Schisandra helped endurance during stressful situations.⁴ As recently as 2002, tea made from Schisandra berries was consumed in traditional Korean Buddhist temples for stimulation and as a tonic.¹⁶ Schisandra has been used traditionally in China, and by indigenous Siberians to promote normal energy levels.^{17,18*}
